 - v. Letters addressed to Attorney General of Texas and Coats Rose, P.C. regarding dating of the Signature ID and No-Litigation Certificate and the General Certificate and Letter to the Comptroller regarding delivery of Initial Bonds;
 - vi. Initial Bonds;
 - vii. Tax Exemption Certificate;
 - viii. Bond Registrar, Paying Agent and Transfer Agency Agreement;
 - ix. Rule 15c2-12 Certificate;
 - x. IRS Form 8038-G; and
 - xi. Take such other actions and execute other documents and certificates necessary to obtain approval of the Bonds by the Attorney General.
- 4. Hear Auditor's Report, including:
 - a. Approve Audit for fiscal year ending May 31, 2024.
- 5. Discuss San Jacinto Regional Water Authority pumpage rate and consider taking action thereon.
