- 4. Hear Report from Roman Forest Police Department and consider taking action thereon, including:
 - a. Proposal for security cameras.
- 5. Hear Garbage Collection Report, discuss garbage contract, and consider taking any action requested.
- 6. Hear Financial Advisor's Report and consider taking any action requested, including:
 - a. Receive and approve 2024 Contract Tax Allocation;
 - b. Adopt Resolution on Development Status of the District under Texas Water Code, Section 49.23602;
 - c. Approve Order Adopting Official Notice of Sale and Preliminary Official Statement for District's Unlimited Tax Bonds, Series 2024 and Contract Tax Revenue Bonds, Series 2024 (together, the "Bonds"); and
 - d. Authorize advertisement for bids for sale of the Bonds.
 - Engage auditor to conduct developer reimbursement audits.

 - e. Authorize and/or ratify construction contracts and related items;
 - f. Approve deeds and/or easements; and
 - g. Approve Summary of Costs for Unlimited Tax Road Bonds, Series 2024.
- 12. Hear Regional Detention/Drainage Maintenance Reports and consider taking any action requested, including:
 - a. Authorize and/or approve proposals for maintenance of regional detention and drainage facilities.
- 13. Hear Developer's Report and consider taking any action requested.
- 14. Hear report from Attorney and consider taking any action requested, including:
 - a. Adopt Resolution Regarding Annual Review of Investment Policy;
 - b. Renewal of District's Insurance Policies; and
 - c. Discuss meeting date and time.
