At this meeting the following items will be considered and acted on:

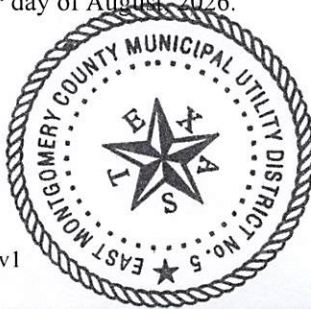
1. Hear from the Public.
2. Consider approving minutes of the meetings held on July 16, 2026.
3. Hear Roman Forest Police Department Report and consider taking action thereon.
4. Hear a report from Waste Management and consider taking action thereon.
 - a. Ratify approval of annual CPI increase.
5. Adopt Resolution on Development Status of the District under Texas Water Code, Section 49.23602;
6. Hear Financial Advisor report and consider taking action thereon, including:
 - a. Receive 2026 Contract Tax Allocation;
 - b. Review 2026 Tax Rate Recommendation; and
 - c. Set public hearing for 2026 tax rate and authorize publication of hearing.
7. Hear Tax Assessor/Collector's Report and take any action requested, including:
 - a. Approve report and authorize payments from the tax account.
8. Hear Operator's Report and consider taking any action requested, including:
 - a. Review billing and collections;
 - b. Authorize termination of water and sewer service to delinquent accounts; and
 - c. Authorize Operator to make necessary repairs to the regional and/or District water and sanitary system.
9. Hear Engineer's Report and consider taking action thereon, including:
 - a. Authorize the design of District and/or Master District facilities;
 - b. Approve plans and specifications for District and/or Master District facilities;
 - c. Authorize Engineer to advertise bids for District and/or Master District projects;
 - d. Approve report, pay estimates, and change orders for construction projects in progress in the District and/or Master District;
 - e. Authorize and/or ratify construction contracts and related items; and
 - f. Hear and update on the District's WSD Bond Application No. 3.
10. Hear Regional Detention/Drainage Maintenance Reports and consider taking any action requested, including:
 - a. Authorize and/or approve proposals for maintenance of regional detention and drainage facilities.
11. Hear Bookkeeper's report and consider taking action thereon, including:
 - a. Approve report and payment of bills listed therein; and
 - b. Approve Master District true-up operating payments.
12. Hear report from Attorney and consider taking any action requested, including:
 - a. Adopt Resolution Regarding Annual Review of Investment Policy; and
 - b. Consider renewal of insurance proposal.
13. Such other matters as may come before the Board.

Government Code, Chapter 551, as amended, the Board of Directors may convene in closed session to receive advice from legal counsel and discuss matters relating to pending or contemplated litigation, personnel matters, gifts and donations, real estate transactions, the deployment, or specific occasions for the implementation, of security personnel or devices and/or economic development negotiations.
